Holdings include notes payable, estate papers, letters, checks, promissory notes, receipts, deeds and invoices. William Hendley and Company was established in 1845 by William Hendley, his brother, Captain Joseph J. Hendley, Captain John L. Sleight, and Phillip Gildersleeve. The firm operated as shipping agents and handled import and export business between Galveston and Atlantic ports. Records are business papers documenting trade with persons and firms in Galveston and the interior of Texas.

Persons and firms associated with our holdings include E. O. Patton, DeWitt C. and Jabez D. Giddings, Albert Ball, John Adriance, Sam Harde- man, Ackerman and McMillam, William Dodsworth, E. J. Hart, Tucker and League, F. W. McMahan, W. P. Ballinger, Welsh and Brother, Charles B. Redfield, Thomas C. Bunker.

Places associated with the records are Brenham; Caney; Plentitude.

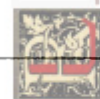

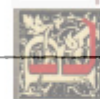
