The Galveston law firm of Ballinger, Mott & Terry represents one of the parties which may include Mrs. Jack. William Pitt Ballinger is the lawyer handling the matter for the firm. Other lawyers who are involved are F. W. Chandler of Austin, TX & Mr. Fisher of Georgetown, TX. H. M. Truehart & Co. and Jos. Franklin are land agents in Galveston, TX. J. K. Guess is unknown to me.
