Reorganized correspondence series of the original Harris Family Papers accession. These papers consist mostly of incoming letters to John W. Harris and his son, John W. Harris, Jr., regarding routine land matters. No attempt was made to separate the letters. John W. Harris, Jr., returned to practice law in Galveston in 1880, and his father did not die until 1887, complicating identification of the letters.

These papers also contain letters addressed to Samuel Harris and Branch T. Masterson.
