They lived at 1117 Thirty-Fourth Street (Block 94, Southeast Quarter). This collection also includes papers of Wilhemina T. (Mrs. A. E.) Leroux, daughter of Anthony Brock and his former wife, Amalia.

The provenance of these papers is unknown. They were discovered in a box in the microfilming room.
